From a Municipal perspective we are losing money. All agree a letter should be sent, but can also see the other side of things with prices rising on everything and money being tight.
- C. HF: Beach Dock: The dock will be back in the water after the first week of July. Supply and Demand are high causing a delay in delivery from Great Northern Docks. The Town is currently trying to sell the smaller 8x8 float because it was to tippy / small for what it was originally intended. Selling for \$2,300.00 which is less then what it was originally purchased for.
