# 11. QUESTIONS OR COMMENTS FROM THE BOARD

- **A.** Sad 17 budget: I thought we were going to put that into next years budget and subtract that from next years. ? AP: They billed it and decided to do it this way. It will go into surplus.
- **B.** Town Office Renovation: RM: The flooring is being done right now. The main office part should be done tonight and then he's going to swap out the two back offices and have them completed by Sunday evening. Countertop was going to arrive tomorrow, but Record Lumber called and said delivery will be next Thursday, because the color chosen was not a stock color. Glenn Snow said he'll come in and install it when it arrives. Once that is done, they will focus on the final product of trim and details.
- C. Recycling Bin Cover: RM: A concerned citizen has been asking about a bin cover for the recycling bin. Jim said they do have them and he is not opposed to providing one, but they do have a cost. The cost with hardware and material to install with everything included is approximately \$2,250-\$2,500.00. Discussion: It's a cover that fits like a tarp. It will not stop people from throwing stuff in, but you can lock them and place signs on top, so that when you're not there, it stands on top of the cover. "Recylcling Only, No Trash". Some people have removed the sign. If residents will respect the cover it's a good purchase. HF: I'm an advocate of signs and letting people know that there is video surveilance. BOS suggest seeing how it goes first with just using signs and then visit it down the road after if needed.
- **D**. Town Plows/ Road crew: RM: Heard some complaints on Social Media after the last storm/blizzard that the Otisfield roads were terrible and that the internal roads were not safe. All agree that most that complain have never plowed and more specifically plowed town roads which is not the same as plowing a driveway. BOS we fully support our road crew, they do long hours and do a great job. All agree that if someone has a complaint they should call Road Commissioner Richard Bean or the BOS. These comments are non-productive.
- E. Road Postings: LA: According to the Bridgton newspaper on road postings, you need an Ordinance on this or BOS need to vote to follow State Law. RM: I believe we have one in place following State Law and requesting we look into this. \*Tabled until an upcoming meeting.
